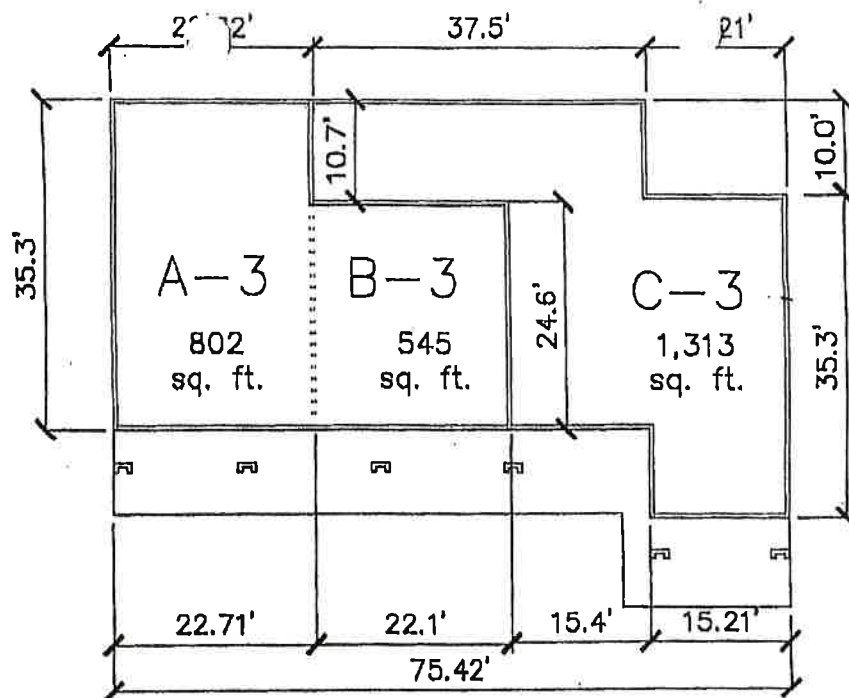

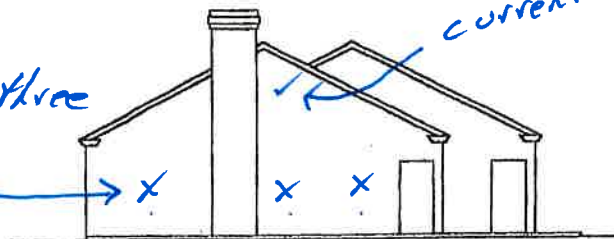

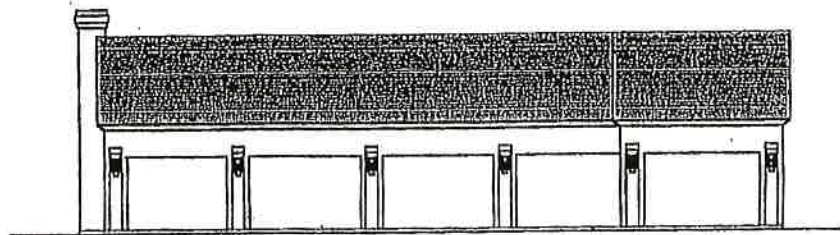


FLOOR PLAN

desired one, two, or three windows 1<sup>st</sup> floor



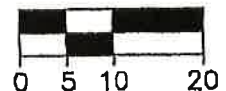
East SIDE ELEVATION
